



## NOTICE OF PUBLIC HEARING BEDFORD COUNTY BOARD OF SUPERVISORS

Notice is hereby given that the Bedford County Board of Supervisors will conduct a public hearing on Monday, August 10, 2015 at 7:00 pm as to proposed update to the Bedford County 2025 Comprehensive Plan initiated by the Bedford County Planning Commission as part of a five year update of the Comprehensive Plan adopted in 2007.
