Safety Reminders:

- **Social Distancing:** Citizens are asked to practice social distancing; social distancing is deliberately increasing the physical space between people to avoid spreading illness. Staying at least six feet away from other people lessens your chances of catching the coronavirus.
- **Self-Quarantine:** People who have been exposed to the coronavirus and who are at risk for coming down with it are encouraged to practice self-quarantine. Health experts recommend that self-quarantine lasts 14 days. Two weeks provides enough time for them to know whether or not they will become ill and be contagious to other people.
- **Small Groups:** The presidential administration has limited gatherings to ten people or less and has asked
